BD Vision's Trades and Commissions Module seamlessly incorporates data imported from any combination of internally developed and off-the-shelf commercial clearance and settlement systems. This module is designed to accept and process trades and commissions data from multiple trading groups, data sources and currencies without the need for customisation. This data is linked directly to a master list of institutional customers and contacts through our state-of-the-art CRM technology. Trade and commission history can be easily searched and filtered by date ranges for an individual customer or across a group of customers, a set of salespeople, or a set of specific securities.

Key Features

Search Tool - Search past trading activity to generate a variety of client trading reports including daily commission runs, granular trade breakdown, net positions by client. Search results can be viewed in any supported currency and easily exported to Excel.

Sales View - Primary and Secondary Account coverage filters allow users to view only executed trades and commissions generated by institutions they are authorized to view.

Commissions Summary - Provides a quick summary of YTD commissions, as well as a detailed breakdown of commissions generated by account.

Trading Summary - Allows for flexible reporting with trade level details including trading volume by account or security.

Analyst View - Presents a volume-only trading summary showing the total number of shares traded in only those securities the analyst covers.

Management Reports - A full suite of built-in management reports including gross revenue by customer, net revenue by customer, trailing 12-months and year-over-year comparisons that are filtered by business unit, branch or individual representative.
